Many residents of Victoria find it challenging to save sufficient funds for a home down payment given the ongoing cost of living crisis. This predicament has led the Victorian Government to introduce a shared equity scheme, aiming to expedite the journey towards owning a home

First Home Owners Grant (New Homes)

The FHOG for Victoria is worth \$10,000 if you build/buy in Victoria.

Most properties such as a house, townhouse, apartment, or unit are eligible for the first home buyers grant in Victoria.

However, the home you're buying must be:

- valued at \$750,000 or less (that is, the contract price of the construction)
- less than five years old
- the first sale of the property as a residential property

Truganina's increasing population is expected to grow by more than 50 per cent over the next 15 years. Affordability, easy access to established schools, shops and public transport and the enormous potential in terms of future amenity make Truganina one of Victoria's best kept property secrets

Buying Off The Plan

Buying off the plan generally involves an extended period between contract exchange and settlement. This gives purchasers the added advantage of having time to get financial affairs in order before settlement takes place. It also gives purchasers the opportunity to secure a property at today's market price with time to organise finance for settlement.

Buying off the plan has in the past led to capital gains, but obviously this depends on many factors such as market conditions, interest rates, etc. As with any investment, external factors always need to be taken into consideration and advice should be sought from independent experts.

At OKAS Property Group Derrimut, our Off the Plan Specialist will be in regular contact as to when you can expect settlement so it does not come as any surprise. You will be provided an opportunity to inspect the property before the due settlement. The Off the Plan Specialist will help you through this process and be available to answer any questions.

Greater Choice

Early purchasers will have a greater selection of what's available in a development, enjoying the opportunity to purchase a property that meets their criteria in terms of position, aspect and floor plan.

Buying a property prior to construction sometimes allows the chance to choose preferred colour schemes and options. This allows you to individualise your property so it's more reflective of your personality. Buying off the plan is a great way to make an apartment your home.

Paying Your Deposit

Holding deposit is \$1,000.
5% of the contract price to be paid within 14 days of signing the Contract of Sale.
Remaining balance to be paid at the time of settlement.

This is commonly paid in cash via Direct Deposit, Cheque, Bank Guarantee or Deposit Bond. Your deposit will be held in a secure trust account by OKAS Property Group Derrimut's Settlement Agent. If you are unfamiliar with Bank Guarantees or Deposit Bonds, our Off the Plan Specialist can provide you with information outlining the correct requirements for using a Bank Guarantee or Deposit Bond to secure your property.



What happens next?

Step one



Signing your contract

Once you have selected the property of your choice with our Off the Plan Specialist and you have signed your contracts and paid the holding deposit of \$1,000, we will then forward one copy to our settlement agent and one copy to your nominated settlement agent, conveyancer or you (if self acting).

Step one



Finalising your contract

From the date of the contract, you will have a further 14 business days from day of sale to pay your initial 5% deposit. Note: at the time of signing a \$1,000 deposit is required.

Step three



Construction of your property

Once your contract becomes unconditional, you will be contacted by our Off the Plan specialist. During the construction period you will be kept updated on key dates and any other relevant information in regards to the progress of your home. Prior to the completion of your new home, we will start to send you information to assist you in the lead up to settlement. This will include such information as your final presentation, a moving guide, brochures and fact sheets and any information to make your settlement as seamless as possible.

Final Presentation

Once your home is completed a detailed Final Presentation is conducted with our Off the Plan Specialist.

Step four



Completion of your home

At your Final Presentation a checklist will be filled out and a copy will be available for your records. This appointment will allow you to speak our Off the Plan Specialist for any queries you may have about your upcoming Settlement.

Step five



At Your Settlement

Once confirmation has been received, the Off the Plan specialist will inform you that your keys will be ready for collection from the OKAS Property Group Derrimut. The Off the Plan specialist will contact you on the day of Settlement to make arrangements with you to arrange this.
